## PROMOTION FROM CLERICAL CADRE TO OFFICERS (JMGS-I) CADRE

We reproduce hereunder the Circular No.42 dated 29.12.2017 issued by Com.Sanjeev K.Bandlish, General Secretary, All India SBI Staff Federation for information of all our members, the contents of which is self explicit.

Dear Comrades,

We have been receiving representations from ex-servicemen employees in clerical cadre that many of them either do not get the opportunity or get very minimal opportunity in the out-of-cadre promotion due to the upper age limit stipulated in the promotion policy, inasmuch as they join the Bank after completion of more than 20 years of service in the armed forces.

2. In order to provide more opportunities to the ex-servicemen employees in clerical cadre for promotion from Clerical Cadre to Officers' Cadre (JMGS-I), we have been pursuing with the management for relaxation of upper age limit in respect of ex-servicemen employees in the Out-of-cadre Promotion Policy and are glad to inform that the bank management has agreed to our above demand and issued necessary circular instructions in this regard, vide e-Circular No.CDO/P&HRD-CDS/77/2017-18 dated 28.12.2017. The brief details are furnished hereunder for the information of our members:

## AMENDMENT IN ELIGIBILITY CRITERIA UNDER DIFFERENT CHANNELS

A) Minimum Service Criteria (ALL GEN/SC/ST)::

Merit Channel - 5 Years with CAIIB and 6 Years without CAIIB

**Normal-Cum-Seniority Channel** – 8 Years

(**For Merit Channel – 5 years with CAIIB** - If an employee becomes eligible after 5 years of service, CAIIB will not be reckoned for the purpose of additional marks since such qualification is now mandatory qualification.)

- B) Upper Age Limit::
  - Merit Channel

Gen: <= 45 Yr SC/ST <= 50 Yr

Ex-Servicemen - Gen: <= 52 Yr SC/ST <= 55 Yr

b. **Normal-Cum-Seniority Channel** 

Gen: <= 50 Yr SC/ST <= 55 Yr

Ex-Servicemen - Gen:  $\leq$  52 Yr SC/ST  $\leq$  55 Yr

- C) Number of Chances::
  - For all channels (TO/Merit/Normal-cum-Seniority)

**4 times** or prescribed age limit, whichever is earlier.
