Circle Committee Meeting held on 5th December, 2020, important decisions

We are happy to inform you that after a long gap, the Circle Committee of State Bank of India Staff Association, North Eastern Circle was held through Google Meet under the chairmanship of Comrade Pranab Thakuria, Circle President. After discussion by the Circle Committee members, following decisions were taken in the meeting.

Homage to the departed members:

At the outset of the meeting, a minute's silence was observed to pay homage to the departed souls of our members who left us during last 10 months. We pray to the Almighty God for the eternal peace of the departed souls.

Signing of 11th Bipartite Settlement:

The Circle Committee extend profound thanks and gratitude to the leadership of UFBU, Specially Com. Sanjeev Kumar Bandlish, Convenor of UFBU, General Secretary of NCBE and All India State Bank of India Staff Federation for signing of the 11th Bipartite Settlement on 11th November, 2020. The details of the agreement has already been circulated vide our Circular No. 17 of 2020.

10th Triennial General Council of SBI Staff Association, NE Circle:

Comrades, as you are aware that 25th April, 2020 was fixed to hold our 10th Triennial General Council which was circulated vide our Circular No.10 of 2020 dated 11th Feb, 2020. But due to pandemic situation for Covid-19 and the restrictions imposed by the Government, we could not hold our Triennial General Council Meeting on that date. After elaborate discussion on the issue, it has been decided to hold the 10th Triennial General Council Meeting at the same venue at Jorhat either on 13th or 14th March, 2021.

As per our Constitution, the Triennial General Meeting of Units have to be conducted to elect a new Unit Committee and to elect the delegate to represent the unit in the Circle General Council. A separate notice will be sent for conducting Unit election and election of delegates to complete the process within the month of January, 2021.

Collection of levy on arrears of 11th Bipartite Settlement:

As you are aware that after every wage revision, Association used to collect certain percentage of levy from our members for strengthening the financial position of Association and to carry on the welfare activities.

After elaborate discussion on the issue by the Circle Committee members, it has been decided to collect Levy @ 1% of the gross arrears at source. (Through HRMS, if allowed) or 1.5% of net arrears to be collected from the members and to be deposited in Account No.10821407940.

We call upon our members to sign the mandate form for collection of levy.
